Process of Meeting with Our Students



Stage 1: APPLICATION/ASSESSMENT

- Tell the student about our program and what services we offer
- Have student complete online Application, available on our website; http://www.lahc.edu/studentservices/financialliteracy/index.html
- Have student complete online Assessment, available on our website; http://www.lahc.edu/studentservices/financialliteracy/index.html
- Set an appointment for the following week/two weeks to complete intake process.

Stage 2: INTAKE/INTERVENTION

- Complete intake sheet and discuss main needs (housing, EdPlan, etc.), current financial situation, and educational plan.
- Discuss resources available for students and provide referrals to academic and community service.
- Set appointment for following week/two weeks to check in with students.

Stage 3: EDUCATION/ ACCOUNTABILITY

- Have students take Pre-Assessment to gather data on information.
- Presentation on financial needs, goals, and budgeting
- Follow-up on previous goals, if completed, set a goal for personal development (financial/educational)
- Set appointment for following week/two weeks

Stage 4: CHECK IN/ PREPERATION

- Student comes in to check in with progress with goals that were set
- Have student take the Post-Assessment
- Have student assist Priority Event
- Present student with reward for completion (TBA)
